COPAC - Some changes for schools in the mission and West Kelowna proposed FSAs - COPAC is en encouraging parents NOT to opt their students out of the Foundational Skills Assessment (Grade 4)

They understand that there is valuable information for schools and districts in them even though there are challenges with how the Fraser Institute takes the data and presents it as school rankings COVID info - Vaccine mandates - the district is still collecting data to decide how to proceed. This is ongoing. This would be a mandate for staff, not students

COPAC has heard that parents are frustrated with the lack of information from IH Merv 13 filters are standard at our schools

When school sports teams are coached by community members those members must be vaccinated (this is a provincial mandate and out of schools control), however teams coached by a staff member do not have the same mandate (the staff member can be unvaccinated)
